In October 2004, the Agency for Persons with Disabilities (APD) became an agency separate from the Department of Children and Families, specifically tasked with serving the needs of Floridians with developmental disabilities. Prior to that time, it existed as the Developmental Disabilities Program.

APD supports individuals with Intellectual and/or Developmental Disabilities (IDD) under Florida's Medicaid Home and Community Based Services (HCBS) Waiver Program.

Individuals may choose to receive services in the community through two types of waivers:

- iBudget
- Consumer-Directed Care Plus (CDC+) requires training, must enroll

An additional option is an institutional setting known as an Intermediate Care Facility for the Developmentally Disabled (ICF/DD).

Typically, you begin receiving services with the iBudget - Ideally it is simple and easy. Most individuals stay on iBudget and hesitate to consider CDC+ for multiple reasons.



Good Waiver Support Coordination is key to both Waivers

- > With ibudget you will get a budget and set amount of funds for the waiver services
- > APD will determine your individual ibudget after considering several factors, including:
 - > Age
 - > Living situation (whether you live with family, in your own home, or in a group home
 - ➤ Kind of support that you need according the agency-approved assessment, called the Questionnaire for Situational Information (QSI).

Why Apply for the Agency for Persons

Current Status for class at North Florida School of Special Education (NFSSE)

- For Children under 18 access to Medicaid
 - Respite
 - Behavioral Services
 - Therapies
- For Adults over 18
 - ▶ The only long-term funding for any services at home and in the community

APD - Who is eligible to apply Must be 3 or older

- Home and Community Based Waiver (HCBW)
 - Down syndrome
 - Intellectual Disability (Full Scale IQ of 70 or below)
 - Autism severe forms
 - ▶ Prader Willie syndrome
 - Cerebral Palsy
 - Phalem-McDermid
 - Spina Bifida (cystica or myelomeningocele)
 - ▶ Individuals between ages 3-5 at risk for a developmental disability

Documents needed to apply APD

As part of the application process APD will request proof of a Developmental Disability Prior to age 18

Intellectual Disability: (IQ below 70)

- All psychological evaluations, with a least one with Intelligence Quotient (IQ) score or Full-Scale IQ (FSIQ) score
- All Individual Education Plans (IEPs) from school and other reports
- All therapy reports (Occupational, Physical, Speech, etc.)
- Any psychiatric evaluations

Autism:

- All psychological evaluations completed at age of 3 to present. (Autism Diagnostic Observation Schedule (ADOS) evaluation)
- All psychiatric evaluations and Records from psychiatric admissions
- All IEPs from school and other reports

All others:

Down syndrome, Spina Bifida (Myelomeningocele or cystica), Cerebral Palsy, Prader-Willi syndrome, Phelan McDermid or high risk 3-5 year olds

Medical documentation and/or chromosomal records (Karyotype for Down syndrome)

- At least one IEP from school
- At least one psychological evaluation, if any had been completed



If you recently applied to APD and did not send ALL the required information, contact APD Eligibility to determine the status of your application.

APD informed The Arc Jacksonville in December 2023 that individuals that did not send in all the required records would be contacted and given opportunity to send it in. Your application is either incomplete and you will receive a request for additional information, or you will be denied for failure to provide the necessary documents as requested.

You also must submit copies: birth certificate, Florida ID (school ID if under 16 is ok), Social Security Card, proof of Guardianship(if applicable), proof of residency (if new to Florida).

- School Records may consist of:
 - Individualized Education Plan (IEP)
 - 504 Plan (Accommodations)
 - Family Service Plan (FSP) (Early Intervention Services)

APD has 60 days after receipt of a complete application to make an eligibility determination

Already on the Waitlist or Pre-enrollment List

- You should hear from APD annually by phone or letter give them important updates
- If there are changes in behaviors, loss of abilities, concerns Keep track of them
- Keep your address, phone and email current never give them a reason to not find you

What does that mean?

Contact APD

- > Stay in touch with APD while on the waiting list -
 - > You should receive an annual call or letter by APD.
 - Communicate changes behaviors, needs, aggression,
 - > Caretaker unable to provide care issues involving health of someone in the home
 - Changes in address, phone number and email
 - Has your child turned 18 Is there now a Guardianship / POA documents should be forwarded
 - Hospitalizations and Baker Acts

APD Services - You got approved for Services

You will be notified by letter that you will be getting services with instructions to pick a Waiver Support Coordinator within 30 days. A list of available WSC will also be provided.

Decisions need to be made, you need to act quickly:

- ▶ Waiver Support Coordinator How to choose?
 - ► Talk to other parents getting services
 - ► Make phone calls and meetings
 - ▶ Use the Waiver Support Coordinator Scorecard


